Notification of Chulalongkorn University

Re: Criteria for Granting Funding for Academic and Research Cooperation

With the University Network and International Institutes under the Second Century Fund, C2F

B.E. 2562 (2019)

Whereas the University Council in the Meeting No. 823 held on 24 January 2019 has approved to proceed with the operation plans of the World Class National University Strategy under "the Second Century Fund, C2F" which gives funding for academic and research cooperation with the university network and international institutes, it is appropriate that there be a Notification of Chulalongkorn University Re: Criteria for Granting Funding for Academic and Research Cooperation with the University Network and International Institutes under the Second Century Fund, C2F B.E. 2562 (2019), in order to proceed with the operation.

By virtues of Article 6 and Article 12 of the Regulation of Chulalongkorn University on Criteria, Conditions, and Procedures for Disbursement B.E. 2562 (2019),

The Meeting of the Deans, as the financial committee, in its meeting No. 31/2562, held on 28 September 2019, has approved the notification, as follows:

Article 1. This Notification is called the "Notification of Chulalongkorn University Re: Criteria for Granting Funding for Academic and Research Cooperation with the University Network and International Institutes under the Second Century Fund, C2F B.E. 2562 (2019)".

Article 2. This notification shall come into force on the date of its announcement.

Article 3. Funding for academic and research cooperation with the university network and international institutes shall be for the objectives of improving strategic cooperation with the university network and international institutes and active operations towards achieving clear academic goals

Article 4. Types of projects under the criteria for support and funding:

(1) Global or regional conferences cooperatively held with research networks, university networks or international institutes, i.e. large-scale academic conferences or exposition with participants from a large number of participants from various countries, and which contribute to global visibility, such as an academic conference & congress, or exhibitions, contests, or cultural expositions cooperatively held on a regional or global scale, whereby university students, lecturers, and researchers participate in the activity. Each project shall receive funding (per project) up to

THB 1,000,000;

(2) Academic or research partnerships with the university network for the purpose of creating high-quality academic works or research recognised on a global scale. This type of criteria aims to promote matching funding or matching research grant proposal on an international scale amongst the university network and international institutes, or aims to undertake in accordance with the criteria and goals determined by the Committee on the Operation Plans of the World Class National University Strategy under the Second Century Fund, C2F. Each project shall receive funding in accordance with its scale, as follows:

(a) Large project up to THB 10,000,000;

(b) Medium project up to THB 5,000,000;

(c) Small projectup to THB 3,000,000.

Article 5. Funding under Article 4 shall be for the following items:

- (1) Reimbursement of actual expenses for traveling, accommodation, pocket money, materials;
- (2) Reimbursement of actual expenses for economy-class flights;
- (3) Expenses other than for (1) and (2), the reasons and necessities of which shall be explained and may be approved on a case-by-case basis.

For Article 4 (2), funding shall cover the costs of academic or research undertakings, but not including durable articles.

Article 6. An applicant for funding shall produce a project proposal and propose it to his or her supervisor, and shall also submit it to the Office of the C2F Operation Plans. The Office of the C2F Operation Plans shall issue a notification to the agencies for acknowledgement, with the following details:

- (1) Form of the project proposal for funding;
- (2) Form of the report; and
- (3) Period for the proposal of the project for funding, every three months.

Article 7. The president or deputy president assigned by the president shall have the authority to consider and approve the project funding, as well as supervising, monitoring, and evaluating the projects. The president may appoint a committee for the consideration of projects under Article 4 to provide supporting comments for approval, as may be appropriate.

Article 8. The grantee shall produce reports on the project results under Article 4, as follows:

- (1) Project report in terms of achievements of the objectives, goals, projects under the stated indicators;
- (2) Financial report; and
- (3) Summary report from the conference, research or policy brief, as the case may be, to be submitted within two months after the termination of the project under the funding contract.

Article 9. Funding under this notification is a regular subsidy. The applicant for funding shall disburse the fund under the items stated in the approved budget plan, and shall maintain evidence of expenses for inspection, in accordance with the university's regulation.

Article 10. The President of the University shall have charge of the execution of this Notification.

In a case where an interpretation is needed or a problem regarding execution of this Notification arises, the matter shall be presented to the President for a decision.
